# Notice of Surcharge Update

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

To comply with new regulatory standards and any potential future requirements across various jurisdictions, ONE will introduce a new surcharge: EUROPE ENVIRONMENT SURCHARGE (EES). In alignment with the <u>announcement</u> made on November 8, 2024, the EES will encompass costs associated with the EU Emissions Trading System (EU ETS) and the FuelEU Maritime Regulation, replacing the current ETS surcharge. This change will take effect from January 1, 2025. The EES will apply to all existing contracts and new contracts that have commenced on and after January 1st, 2025. The tariff shall be reviewed quarterly; however, this is subject to change with prior notification.
